## Viacom's Insurers Must Face Coverage Suits Over CBS Merger

Law360 (February 17, 2023, 5:51 PM EST) -- A Delaware state judge ruled that several of Viacom's directors and officers insurance carriers must face the media company's suits seeking coverage for litigation stemming from its merger with CBS, deeming the dispute ripe for consideration.

Superior Court Judge Abigail M. LeGrow determined in an **opinion and order** Thursday that two separate insurance coverage suits brought by Viacom Inc. and Shari E. Redstone, who was a member of Viacom's board of directors at the time of the 2019 CBS **merger**, are ready for adjudication.

Viacom and Redstone are seeking coverage from insurers under Viacom's 2016 and 2019 D&O towers for damages they might be ordered to pay, whether by settlement or judgment, in the underlying actions.

The underlying actions accuse the directors, officers and controlling shareholders of Viacom and CBS of breaching their fiduciary duties in connection with the 2019 merger.

According to court filings, the insurers have paid defense costs but refuse to provide coverage for a judgment or settlement for various reasons, such as arguments that certain exclusions bar coverage for

damages as well as a dispute over which policy period is implicated in the underlying actions. Some of the 2019 tower insurers have taken the position that the 2016 tower is implicated by the claims in the underlying actions, rather than the 2019 tower.

Because of the disagreement about which policy tower is implicated by the claims, insurers in both the 2016 and 2019 towers were named as defendants in the coverage fight, according to the judge's ruling.

Some of the insurers filed motions to dismiss the coverage fights, arguing that those disputes won't be ripe for consideration until the underlying actions have been resolved.

But the judge said Thursday that the insurance disputes are ripe because "concrete facts" can be used now to resolve issues over the meaning of exclusions and which policy period is applicable.

Counsel for Viacom declined to comment Friday.

Representatives of the other parties did not immediately respond to requests for comment.
